



REQUEST FOR PROPOSAL UNIFORM VENDOR

Boerne Soccer Club, an affiliation of the Alamo Area Youth Soccer Association (AAYSA), is a non-profit corporation whose purposes are: teaching the fundamentals of soccer to youth participants and adult sponsors; advocating and developing the principals of good sportsmanship and promotion of good physical and mental health through participation in sports; and the promoting of soccer through sponsorship of regularly scheduled youth soccer competitions.

The Boerne Soccer Club (BSC) is seeking a Uniform Vendor (hereafter called Vendor) to provide uniforms to Boerne Soccer Club for the upcoming Seasonal Year (Fall 2008 and Spring 2009).

Boerne Soccer Club (BSC) Team Colors: Our competitive or “select” teams wear navy, red, & white. We prefer all three colors to be incorporated in the design.

Vendor shall be able to provide uniforms for each of our leagues at varying requirements. Here is a brief description of those leagues:

- **Recreational League:** *Stock* uniforms in 16 or more colors for recreational teams. Each uniform kit will include: 1 numbered jersey, 1 pair of shorts, and 1 pair of socks. We need to be able to order quantity by color as needed.
- **Academy League:** *Medium* quality uniforms utilizing the BSC Team Colors (preferably). Uniform kits must include: 2 numbered jerseys (home and away), 1 pair of shorts, and 2 pair of socks.
- **Select League:** *Premium* quality uniforms that will last 2 seasons (preferably 2 years/4 seasons), made of a moisture wicking type material and temperature management technology (e.g. Dri-FIT). Uniform kits for select teams will utilize the BSC Team Colors and will include: 2 numbered jerseys (home and away), 1 pair of shorts, and 2 pair of socks.

In addition to uniform kits, we are also interested in backpacks or duffel bags along with training/warm-up suits. These items would primarily be for the Select League. However, we may choose to offer these types of items as fundraisers for the Club. When considering quantities for these items, use those noted for the Select League. These would also utilize the BSC Team Colors.

REQUEST FOR PROPOSAL UNIFORM VENDOR

Fabric: The uniforms shall be guaranteed against manufacturer defects and workmanship. We prefer a moisture wicking, 'sport' fabric versus polyester or nylon.

Logo: Our logo, shown above, is to be silk-screened on each jersey. Logo may be black & white for the Recreational League, but is expected to be color for the Academy & Select Leagues. Artwork must be approved prior to production – via live sample.

Delivery/Shipping: Uniform kits are to be packaged & labeled by team number as per each order. They are to be shipped via bonded, commercial courier (i.e. UPS, DHL, FedEx, etc.) using standard ground services. However, Vendor should also have the ability to utilize overnight shipping as required/requested by approved contact within BSC.

In addition to the additional uniform kits that we anticipate ordering for the Spring season, we anticipate needing additional pieces to complete sets from the prior season. Therefore, Vendors should propose both kit/package pricing as well as individual piece pricing.

Soccer Start/Financial Hardship: As a part of our mission, we have a very active “Soccer Start” program that targets disadvantaged children in rural, suburban and urban areas who need an activity outside of school. In addition, there are others whose families are having a temporary hardship situation. We have anywhere from 60 up to 100 children playing soccer within the league each season that match this description and are unable to pay for services. Special consideration will be given to those Vendors who offer up various quantities for each League to assist with these expenses.

Individuals interested in submitting a bid should submit a proposal/price quote including company bio, product samples, promotional items, warranties, and references. The BSC Executive Board will review these proposals and determine whether the proposal is acceptable. Special consideration will be given to Vendors who offer team/coach gifts such as training equipment, coaches shirts/bags, goalkeeper jerseys, etc.
